## EXCEPTION AGREEMENT BETWEEN MCLEOD COOPERATIVE POWER ASSOCIATION AND THE CITY OF BROWNTON

**THIS AGREEMENT**, made this 7<sup>th</sup> day of February, 2023, by and between MCLEOD COOPERATIVE POWER ASSOCIATION, a corporation organized under the laws of State of Minnesota (hereinafter referred to as "the Cooperative") and the CITY OF BROWNTON, a municipal corporation organized under the laws of State of Minnesota, by its Brownton Utilities Commission (hereinafter referred to as "the City"), individually or collectively referred to as a "Party" or "Parties".

## **RECITALS**

**WHEREAS**, the Cooperative and the City each have electric service areas assigned by the Minnesota Public Utilities Commission in which the Parties have exclusive rights to provide electric service to customers within their respective territories; AND

**WHEREAS**, the River's Edge Concrete, LLC is seeking electric service from the City located at 335 3<sup>rd</sup> St S, Brownton, Minnesota ("Customer") within the City's service territory; AND

WHEREAS, the City does not have electrical facilities near the Customer property; AND

WHEREAS, the Cooperative does have electrical facilities near the Customer's property; AND

**WHEREAS**, the Customer requests to have its electric service provided by the Cooperative from its electrical distribution system; AND

**WHEREAS**, the Parties have come to a mutual agreement that will allow the Cooperative to provide electric service by exception to the Customer's premises within the exception area.

**NOW, THEREFORE**, in consideration of the promises exchanged herein, the Parties agree as follows: <u>Scope of Agreement</u>: The scope of this agreement is limited to commercial electric service within the exception area specifically identified on <u>Exhibit</u> "A" attached hereto and incorporated herein, and legally described as:

That Part of the Southeast Quarter of the Northwest Quarter (SE1/4 of NW1/4) and that part of Government Lot Four (4), all in Section Thirty-one (31), Township One Hundred Fifteen (115), Range Twenty-nine (29), described as follows: Commencing at the southwest corner of said Southeast Quarter of the Northwest Quarter; thence North 00 degrees 09 minutes 12 seconds East, assumed bearing, along the west line of said Southeast Quarter of the Northwest Quarter 827.47 feet to the point of beginning of the land to be described; thence North 89 degrees 09 minutes 18 seconds East, parallel with the south line of said Southeast Quarter of the Northwest Quarter 605.39 feet; thence North 00 degrees 09 minutes 12 seconds East, parallel with said west line and parallel with the west line of said Government Lot 4 a distance of 941.93 feet to the centerline of County Highway No. 32 (formerly U.S. Highway No. 212); thence southwesterly 640.71 feet along said centerline, along a nontangential curve concave to the south, said curve has a radius of 1910.08 feet, a central angle of 19 degrees 13 minutes 09 seconds and a chord bearing of South 71 degrees 48 minutes 31 seconds West to the west line of said Government Lot 4; thence South 00 degrees 09 minutes 12 seconds West along said west line of Government Lot 4 and along said west line of the Southeast Quarter of the Northwest Quarter 751.77 feet to the point of beginning.

EXCEPTING THEREFROM Parcel 207 of Minnesota Department of Transportation Right of Way Plat No. 43-9, according to the recorded plat thereof.

This property is located in McLeod County, State of MN Parcel ID# 13.031.2100

<u>Compensation</u>: The Parties agree that the Cooperative shall compensate the City for the transfer of the Customer in the amount of a one-time payment of \$1,500.00, due and payable prior to the electric service being energized for the Customer service.

<u>Facilities Costs</u>: The Cooperative shall install the required facilities to the termination point on the Customer's property.

<u>Reservation of Rights</u>: Except as specifically set forth herein, this Agreement does not modify or limit the legal rights of any Party.

<u>No Precedent</u>: The Parties recognize that this agreement is the result of negotiations between the Parties and does not represent any binding or legal precedent on any party in any other matter.

<u>Agreement Drafted Jointly</u>: The Parties agree that none of the Parties shall be deemed solely responsible for drafting all or any portion of this Agreement, and in the event of a dispute, responsibilities for any ambiguities arising from any provision of this Agreement shall be shared equally among the Parties.

<u>Effective Date</u>: The effective date of this Agreement is the date upon which the Agreement has been signed by a duly appointed representative of both Parties.

<u>Term of Agreement:</u> The initial term of this Agreement shall be for a period of one hundred twenty (120) months commencing on the first day of the first month following the effective date of this Agreement and continuing on a month-to-month basis thereafter, unless terminated sooner as provided in this Agreement.

<u>Termination of Agreement:</u> Upon the expiration of the initial term of this Agreement, either Party may terminate this Agreement for any reason by either Party giving to the other Party sixty (60) days' written notice.

<u>Notice</u>: Any notice permitted or required by this Agreement shall be made in writing and personally served or mailed (postage prepaid, return receipt requested) and shall be effective upon the date of personal service, or if by mail, upon the date of receipt.

**IN WITNESS WHEREOF**, the Parties hereto have caused the Agreement to be executed as of the day and year first above written and the Parties agree to take such additional steps and actions including execution of such instrument and other documents as are reasonably necessary to effectuate the expressions hereby.

**THE FOREGOING AGREEMENT** was introduced and moved for adoption by Council Member Carrigan, seconded by Council Member Messner and with all present voting in favor thereof, said resolution was declared duly passed and adopted. **2023 – 013**
